**Assembly, Stable Departure, and Post Procedure:**

- In an effort to make this as efficient as possible, those horses entered in first heat will leave the assembly area at 11:40 pm as posted and proceed to the stewards stand and then the start. Immediately following, those entered in the next heat will circle in the assembly area tacked up and ready to go. Upon completion of the first heat, those horses will be ridden back to the assembly area and dismounted. Horses for the second heat will immediately depart the assembly area and follow the procedure used in the first heat. The subsequent heats will be run similarly.
- Given the fact that there are no scales and the desire to run on time, all are asked to bring the necessary tack to allow jockeys to run in back to back heats w/out delays.
- We will do our best to adhere to our HIST schedule.

- Stalls- the Legacy Chase stalls will be available for use during the trials.
- Designated Assembly Area- Area in Stabling Field East of the Big Sycamore Tree.
- Van Parking- East of Stalls & the Designated Assembly Area.
